Only personal checks or credit cards can be accepted on RPAC contributions due to Rhode Island Law.

RPAC contributions are not deductible for income tax purposes. RPAC contributions are voluntary and used for political purposes. You may refuse to contribute without reprisal or otherwise affecting your membership rights. 70% of your contribution goes to your State Association to support state and local political candidates. 30% is sent to National RPAC to support federal candidates against your limits under 2 U.S.C. 441a.

1. Copy of your real estate or appraisal license.
2. A completed application for REALTOR® membership with your payment included.
3. A letter of affiliation from the Principal or copy of license transfer form filed with DBR.
4. A Board Certification Form if you are a new Principal/Office.
5. If you are transferring from another Board, please provide a letter of good standing from your previous Board.
6. If you are transferring from another Board, please provide a copy of your Code of Ethics class certificate for the 1/1/17 - 12/31/18 biennial.
